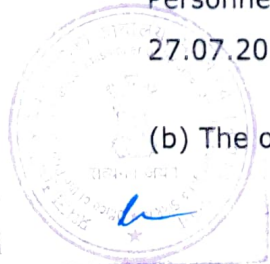
Part-I: PROMOTION:
