(Pay-I) dated 12.12.1997.

(c) The above officers promoted to the post of Senior Private Secretary vide this order are liable to be reverted to the post of Private Secretary without prior notice at any time.

(d) The persons concerned will please note that in the event of refusing promotion even after the availability of the concession mentioned in Ministry of Personnel, Public Grievance & Pension (Deptt. of Personnel & Training)'s O.M.
