
**Sub:** Deviations from T&P Policy found in the Annual General Transfer Orders for  
the Posts of ACIT/DCIT/JCIT/Addl. CIT- Request for Rectification-matter reg.

**Ref:** *Your corrigendum or orders following the AGT Order No. 96 of 2014 dated 27.08.2014  
for Addl.CIT/JCIT and Order No. 102 of 2014 dated 27.08.2014 for ACIT/DCIT*

Kindly refer to the above.

With heavy heart we would like to point out that in spite of two corrigendum orders passed the AGT(2014) orders, both for Addl.CIT/JCIT and for ACIT/DCIT suffer from a number of deviations. We had made our position very clear before the placement committee headed by you and had requested your goodself to abide by the accepted transfer posting guidelines. In between we have addressed several letters to your goodself pointing out the aberrations and seeking corrections thereof. However, to our surprise we find the chair of Pr.CCIT which should be impartial being the head of the Income Tax family in West Bengal & Sikkim is blatantly inclined towards the direct recruited officers, who have been favoured in Annual General Transfer Orders, 2014 for the Posts of JCIT/Addl. CIT/DCIT/ACIT and subsequent corrigendum orders at the cost of promote officers giving the T&P guidelines a total go-bye.

In spite of several representations against apartheid like 50-50 formula for corporate postings the placement committee has stuck to its nefarious design of dividing the officer folk along the line of direct and promotee officers. While seniority should have been the sole criteria for posting in Corporate charges and Muffassil charges the placement committee has chosen to ignore this aspect thereby intentionally violating T&P Policy.

It may be reiterated that DCsIT like Sri Supriyo Pal (06596), Sri Sankar Kumar Halder (06635), Sri Bikash Chandra Biswas (06636), Dr. Anup Biswas (06640) Sri Jayanta Mridha (06641) and Sri Supriyo Biswas (07509) have not been considered for corporate posting while officers junior to them have been posted to corporate charge. Similarly JCsIT like Sri Randhir gupta(01625), Sri Sanjay (01691), Sri Snehotpal Dutta (01976), Sri R.P. Nag (01982), Sri Dilip Rakshit (01992), Sri A.P. Roy (011000) etc. have been ignored for corporate postings.

That the administration is bent upon passing the orders according to its whims and fancies is clear when posting orders have been hurriedly passed for a newly promoted ACIT(sole exception) while CBDT has specifically mentioned they should be kept in situ. Likewise Direct recruit officers (like Sri N.K.B. Singh, Ms Rintei Rinthlei etc.) have been given assessment charges in spite of completion of 4 years of continuous assessment [or DG (Inv.)] posting while the promote officers have been removed from assessment charges just after the 3<sup>rd</sup> year. When the glaring deviations and violations in those orders have been brought to the notice of your good office, the administration has not only ignored them, rather it has resorted to vindictive transfer of promote officers. Even Sri Sumit Roy (07508), our Vice President has been given additional charge of Burdwan ( a muffassil charge) when he is holding the charge of building -in -charge of Bamboo Villa although several direct recruit officers, much junior to him have been posted in Kolkata and not given any additional charge in muffossil.

The administration is required to be reminded that the ITGOA in West Bengal believes in sorting out the anomalies through mutual dialogues. But we request your goodself not to mistake our patience as sign of weakness. We, therefore, request you to pass suitable corrigendum order immediately rectifying the aberrations brought to your notice which could not be set right in spite of two corrigendum orders in each categories. If the anomalies are not set right by the 25<sup>th</sup> of this month we will be constrained to resort to the path of agitation and we will have no option but to let the CBDT know that the high handedness and policy of favoritism of the local authorities is entirely responsible for this impasse.
