- (iii) The promotion is valid for one year or till his reversion to the feeder cadre or regulation of such promotion, which ever is earlier, in terms of Para No.5 of DoPT OM No.28036/8/87-Estt.(D), dated 30.03.1988, unless it is further extended as per releavent rules.
- (iv) The official is not entitled to exercise any option for fixation of pay as provided under F.R.22(1)(a)(1) since the promotion on ad-hoc promotion basic.

  undersigned on or before 29.10.2019.
