  - The official is liable to be reverted to their present cadre at any time without assigning any reason,
  - The promotion is valid for one year or till his reversion to the feeder cadre or regulation of such promotion, which ever is earlier, in terms of Para No.5 of DoPT OM No.28036/8/87-Estt.(D), dated 30.03.1988, unless it is further extended as per releavent rules.
  - The official is not entitled to exercise any option for fixation of pay as provided under F.R.22(1)(a)(1) since the promotion on ad-hoc promotion basic.

4. This promotion is subject to any subsequent O.M./Clarification/Instruction from DoP&T/CBDT regarding the procedure of implementation of the judgement of the Hon'ble Supreme Court dated 26.09.2018 in SLP(C) No.30621/2011, or any such other judgements of the Supreme Court in this regard.

5. The official who has been given the benefit of pay fixation under the ACP Scheme, 1999/ MACP Scheme, 2008, in the same grade pay/pay level will not be eligible for any pay fixation on above promotion.

6. The official concerned is directed to join his new assignment on or before 29.10.2019. If, however he is unwilling to accept such promotion, an intimation that regard shall be sent to the office of the undersigned on or before 29.10.2019.
