**Part-I : PROMOTION:**

- (e) The officials concerned are liable to be reverted without prior notice at any time. The posting on promotion is purely temporary and they are liable to be transferred within West Bengal at any point of time.
- (f) The persons concerned may please note that in the event of their refusing promotion even after the availability of the concession mentioned in Ministry of Personnel, Public Grievance & Pension (Deptt. of Personnel & Training)'s O.M. No. already cited above he would be debarred from promotion for a period of one year from the date of refusal of said promotion or till the next vacancy arises, whichever is later, as per the D.O.P&T's O.M.No.22011/5/91-Estt.(D) dated 27.03.1997.
