
**OFFICE ORDER NO. 15 of 2025**

2. Their names stand deleted from the Office Order no. 350 of 2024 dated 31.12.2024. As per DOPT's OM No. 22011/5/86-Estt.(D) dated 10.04.1989, **they are debarred for regular promotion to the grade of Assistant Commissioner of Income Tax for a period of one year from the date of refusal of promotion or till a next vacancy arises, whichever is later. On the eventual promotion to the higher grade, such Government servant will lose seniority vis-à-vis his juniors promoted to the higher grade earlier irrespective of the fact whether the posts in question are filled by the selection or otherwise.**
