Part-I : PROMOTION

(c) The above person may exercise option under FR 22, within one(1) month from the date of this order, to have his pay fixed either with effect from the date of appointment on such promotion or with effect from the date of accrual of next increment in the feeder grade. Option once exercised shall be final.

(d) The official concerned is liable to be reverted without prior notice at any time. His posting on promotion is purely temporary and he is liable to be transferred within West Bengal at any time.

(e) The person concerned may please note that in the event of his refusing promotion even after the availability of the concession mentioned in Ministry of Personnel, Public Grievance & Pension (Deptt. of Personnel & Training)'s O.M. No. already cited above he would be debarred from promotion for a period of one year from the date of refusal of said promotion or till next vacancy arises, whichever is later, as per the D.O.P & T's O.M.No.22011/5/91-Estt.(D) dated 27.03.1997.
