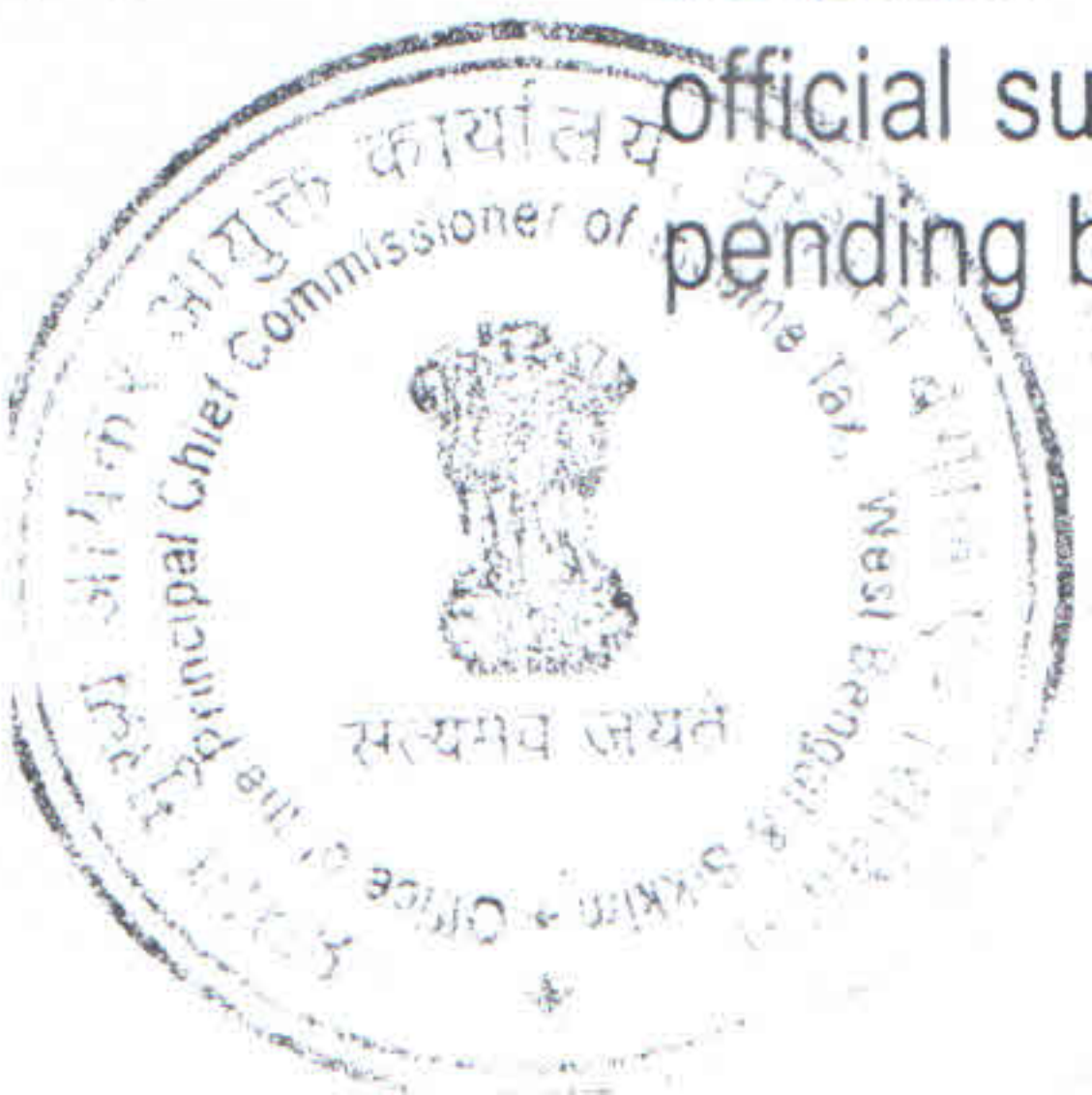
In pursuance of the Recruitment Rules Part-II, Section 3, Sub-section-(i) of Gazette of India on 14.04.2007 as sent to this office vide Board's letter dated 26.06.2007 issued from F.No.A-12018/02/2004-Ad-VI(A), the following **Stenographers Gr.I** are hereby promoted to the grade of Private Secretary in the Level-7 ( Pre revised Pay Band Rs.9,300 – 34,800/-, Grade Pay Rs.4600/-), on **Ad-hoc** basis against the Vacancy Year 2018.

**2. Posting:**

On promotion, the officials will continue to discharge their functions and duties on **in situ** basis at their respective present office(s), until further orders.

3. The officials are informed that their seniority is liable to be changed due to judicial/administrative orders.
4. The appointment is purely on **Adhoc** basis and the officials are liable for reversion at any time, if found necessary.
5. The Adhoc promotions are subject to the following conditions:
  - (i) The Adhoc promotion shall not confer on the officials concerned any right to claim seniority in the grade of P.S. or regular promotion as P.S.;
  - (ii) The officials are liable to be reverted at any time without assigning any reason,
  - (iii) The promotion is valid for one year in terms of Para No.7 of DoPT OM No.28036/1/2001-Estt.(D), dated 23.07.2001.
  - (iv) The officials are not entitled to exercise the option provided under F.R.22(1)(a)(1) being ad-hoc promotion. They will be entitled to exercise the option on the regularization against regular vacancy.
- 5.1 In addition to the above-mentioned conditions, the promotions of the above officials are purely provisional and are liable to be reverted to their present cadre without assigning any reason whatsoever including the following conditions:-
  - (i) If after a review of vacancies, it is found that their promotion is in excess of the vacancies available or if any candidate is omitted for any reason becomes eligible for promotion subsequently;
  - (ii) Their seniority will be liable for reconsideration/refixation in the event of any claim of seniority that may be filed at any point of time, upon being found correct, with reference to the records that the claim is correct;
  - (iii) The promotions of the above officials are based on revised seniority list published after giving effect to the decision of N.R.Parmar and Ors. Vs Union of India and Ors. and is subject to change in seniority of any official subsequent to any representation received later on by this office and/or decision of any proceedings pending before any Tribunal/Court/CBDT/DoPT;

6. The above promotions are made against the Vacancy Year 2018 on ad-hoc basis.
7. This promotion is subject to any subsequent O.M/clarification/ instruction from DoP&T/CBDT regarding the procedure of implementation of such judgement of the Hon'ble Supreme Court dated 26.09.2018 in SLP(C) No.30621/2011, or any such judgement of the Supreme Court in this regard, the above officials are liable to be reverted at any time without assigning any reason, as a consequence of it.
8. They are however informed that they are liable to be reverted to the lower post if after review of the vacancies or for administrative reasons or in compliance to any Court's order it is considered necessary to revert them.
9. The officials who have been given the benefit of pay fixation under the ACP Scheme, 1999/ MACP Scheme, 2008, will not be eligible for any pay fixation now.
10. The persons concerned may please note that in the event of their refusing promotion he/she would be debarred from promotion for a period of one year from the date of refusal of said promotion or till the next vacancy arises, whichever is later, as per the D.O.P&T's O.M.No. 22011/5/86-Estt.(D), dated 10.04.1989 read with 22011/5/91-Estt.(D) dated 27.03.1997.
11. On promotion as P.S. the above named officials are posted in the same office where they were posted before the promotion and shall perform the duties of P.S. in addition to their earlier duties assigned to them with effect from the date they take up the charge and until further orders.
12. Postings on promotion mentioned in this order are purely temporary and the officers are liable to be transferred within West Bengal Region in future.
