However, many representations were received thereafter also and accordingly comprehensive exercise to identify discrepancies was taken up and a list of 221 officers was put up on IRS portal vide letter F. No HRD/PMD/Civil List/401/1/2017-18/3260 dated 18.09.2017. (Copy enclosed). The PCCsIT(CCA) were requested to do necessary verification from service books/office record of the respective officers.
- 4. However, till date the details of 108 officers (As per annexure-A) are yet to be verified by their respective charges.
- 5. Therefore, I have been directed to again request you to verify the above discrepancies from the service records of these officers or any other relevant office record and to furnish a certified copy of the corrected information, latest by 12<sup>th</sup> October, 2017 by 04.00 PM through email on rajeev.kumar@incometax.gov.in under the subject- Civil List as on 01.03.2017 without fail.
- 6. Since, there will not be any further possibility to correct these errors once the Civil List is finally printed, the matter may kindly be accorded top priority.
