Kindly refer to the above.

- 2. Vide the above referred letter, it was requested to send the information about the details of the orders of High Court(s) which are not being challenged before the Hon'ble Supreme Court by sending Proforma B1 through e-Office.
- 3. However, the Directorate has received very few Proforma B1s in the calendar year 2024. The details of Proforma B1s received in this Directorate since December 2023 is tabulated in the enclosed sheet.
- 4. Considering the importance of maintaining a comprehensive database in respect of all orders of High Courts including the ones which are not being challenged by the field offices, I am directed to request the jurisdictional Pr. CIT/CIT to submit the copy of Proforma B1 to the Pr. CCIT concerned instead of sending the file to the Directorate through e-Office. It is requested that the Pr. CCsIT may collate all such Proforma B1s and send the copy thereof to this Directorate on monthly basis by email @ delhi.ddit.lr.tech@incometax.gov.in by the 5<sup>th</sup> of every month.



Sub: Filing of PROFORMA-B1 for cases where Appeals/Special Leave Petitions are not recommended -regarding.

The Directorate of L&R maintains LRTS database containing information in respect of all Appeals/ Special Leave Petitions processed and filed by the Directorate. Information in respect of cases where SLP proposal are received but SLP is not filed is also maintained in the LRTS database. However, cases where appeals/ SLPs are not proposed by the field are not maintained in the LRTS database.

- 2. To maintain comprehensive database in respect of High Court orders including those where proposal for SLP is not submitted by the field, it has been decided that information in respect of High Court orders where Appeals/Special Leave Petitions are not recommended by the field formation, shall be submitted to this Directorate in Proforma-B1 attached with this letter.
- 3. I am, therefore, directed to request you to direct all officers within your region to send the information in respect of all cases in which the order of the High Court is not contested by the field formation. The information shall be sent through E-Office, as in the case of SLP proposal, in the Proforma-B1 enclosed herewith.
