2. The Adhoc promotion is subject to the following conditions:

(i) The Adhoc promotion shall not confer on the official concerned any right to claim seniority in the grade of ITO or regular promotion as ITO;

(ii) The official is liable to be reverted at any time without assigning any reason.

(iii) The promotion is valid for one year or till their reversion to the feeder cadre or regularization of such promotion, which ever is earlier, in terms of Para No.5 of



DoPT OM No.28036/8/87-Estt.(D), dated 30.03.1988, unless it is further extended as per relevant rules.

(iv) The official is not entitled to exercise the option provided under F.R.22(1)(a)(1) being adhoc promotion. He will be entitled to exercise the option on the regularization against regular vacancy.

3. The continuation of above promotion both ad hoc and regular is further subject to:

- a. Implementation of any instructions/guidelines which may be issued by CBDT/HRD in compliance to the judgement delivered by the Hon'ble Supreme Court in the case of Pratibha Rani & Ors, Versus Union of India & Ors.
- b. Any other order/judicial pronouncement of any court or instructions/guidelines issued by CBDT/DoPT/HRD in this regard.
