- The Seniority list/AIISL of ITOs in respect of MP & CG Region has been 2. challenged before the CAT, Jabalpur. It has been informed by the concerned region that Suni A. Kumar Vs. Ors, MP & CG Region & others have filed an OA No. 829/2024 and M.A. No. 1620/2024 before Hon'ble CAT, Jabalpur Bench wherein Hon'ble Tribunal passed an interim order dated 12.12.2024 in MA No. 1595/2024 and directed not to proceed further with the DPC till further orders. However, the Hon'ble Tribunal, vide subsequent order dated 23.12.2024, modified its earlier order dated 12.12.2024 to the extent that DPC for the Madhya Pradesh and Chhattisgarh Region only shall be deferred till further orders. Therefore, eligible ITOs from MP&CG region will be considered after the Hon'ble Tribunal decides the cases.
- The Seniority list/AIISL of ITOs in respect of AP & TS Region has been 3. challenged before the CAT, Hyderabad. It has been informed by the concerned region that Shri R. S. R. Murthy & 05 others have filed an OA No. 1835/2024 before Hon'ble CAT, Hyderabad Bench wherein Hon'ble Tribunal passed orders dated 14.11.2024, 7.03.2025, 24.03.2025 & 27.03.2025 and directed to exclude the ITOs from AP & TS region from the DPC till the final outcome of the CAT. A similar order dated 27.03.2025 in OA No. 788/2022 filed by Shri Abhishek kumar Jha & Ors. Directing that the DPC for Telangana & AP Region only shall be deferred till further orders has been passed. Therefore, eligible ITOs from AP &TS region will be considered after the Hon'ble Tribunal decides the cases.
- Accordingly, the appointments of these ITOs as ACIT on ad-hoc basis shall also be subject to the final outcome of the court case(s) in the matter of Shri R. S. R. Murthy, ITO, AP & TS region & Ors. Vs. Union of India, Shri Abhishek Kumar Jha, AP & TS region & Ors. Vs. Uol and in the matter of Shri Suni A. Kumar Vs. Ors. MP & CG Region & Others.
- The Principal CCIT (CCA) concerned shall ensure that the names of the officers, who have expired/superannuated/resigned/taken VRS before the date of issuance of the appointment order in ACIT grade on ad-hoc basis, their names may

be treated as deleted from the appointment order in terms of DoPT O.M. dated 14.11.2014 and an information sent to this office.

- 6. Further, all Principal CCIT (CCA) and all other concerned supervisory authorities shall also ensure that all the officers shall be clear from vigilance and administrative angle8888 before assuming the charge of the post.
- 7. These appointments are subject to outcome of the Orders that may be passed by the Hon'ble Supreme Court in Jarnail Singh and Ors. Vs Lachhmi Narain Gupta and Ors (Civil Appeal No. 629 of 2022 arising out of SLP (C) No. 30621 of 2011], Hariharan Vs. Harshvardhan Singh Rao case and other connected matters of any other Court case (s) before Hon'ble Court/Tribunal. Further, this order is subject to outcome of any other court case(s) pending in any court of law in India.
- 8. All the Pr. CCsIT/Pr.DGsIT are requested to ensure that compliance reports to this order be sent to the board within 15 days. In case, any officer submits any representation as to decline to accept promotion, the same may be forwarded to the Board for consideration of the Appointing Authority. All the relieving and joining should mandatorily be done by 11.04.2025 by the officer concerned and approved by the concerned Pr. CCIT (CCA) on line on www.irsofficeronline.gov.in
