Subject: Procurement of laptops under the 'Information Technology Procurement, Obsolescence and Disposal Policy - Laptop' of 2015 - Reg.

I am directed to refer to this office letter no. F.No Pr.DGIT(S)/ADG(S)-4/Laptop Policy/2014-15/18-19/ dated 24-10-2018 on the above subject, vide which the SOP and Technical Specifications of five categories of Laptops were circulated.

As per the SOP, the procurement of laptops for the eligible officers of each Region is to 2. be aggregated at the level of Pr.CCIT(CCA) for the Region. With reference to the procurement of the laptops on Government e-Marketplace (GeM), the following has been conveyed by GeM:

"Dedicated Category namely "Laptops for Income Tax" is being created on portal to fetch five variant of Laptops as per your specification sheet. The specifications are also being uploaded on the GeM portal."

Besides, certain issues regarding the specifications including non availability of software like Office 2016 were flagged by GeM. The issues flagged were referred to the Technical Specifications Committee (TSC) formed for the purpose of making recommendations regarding the Technical Specifications of Laptops.

In this regard, I am directed to state that the issues raised by GeM and the decisions taken **3.** in respect of each of them (under the column "Response") are as under:
