- (i) The Adhoc promotion shall not confer on the officials concerned any right to claim seniority in the grade of AO, Grade-III or regular promotion as AO, Grade-III.
- (ii) The officers are liable to be reverted at any time without assigning any reason,
- (iii) The promotion is valid for one year or till their reversion to the feeder cadre or regularisation of such promotion, which ever is earlier, in terms of Para No.5 of DoPT OM No.28036/8/87-Estt.(D), dated 30.03.1988, unless it is further extended as per releavent rules.
- (iv) The officers are not entitled to exercise the option provided under F.R.22(1)(a)(1) being adhoc promotion. They will be entitled to exercise the option on the regularization against regular vacancy.
