OFFICE MEMORANDUM

After enactment of the Rights of Persons with Disabilities Act, 2016(herein after referred as RPwD Act, 2016) some new categories of disabilities(autism, intellectual disability, specific learning disability and mental illness, Multiple disabilities) are also entitled for reservation. Department of Empowerment of Persons with Disabilities (DoEPwD) has stated that they are in process of identification of the posts suitable for persons with benchmark disabilities. They have requested to constitute an Expert Committee in the respective Ministries/Departments for identification of the Services for categories of disabilities for the implementation of the same in the Civil Services Examination, 2018.

Therefore Income Tax Department has constituted a committee comprising of following members:


