Minutes of the meeting held with JCA under the chairmanship of Chairperson, CBDT on 20-10-2015:

A meeting was held in the chamber of Chairperson, CBDT on 20-10-2015 with the representatives of Joint Council for Action of ITEF and ITGOA with regard to the ongoing agitation and the discussion held by the Chairperson and Member (P&V) with Revenue Secretary on this issue. The list of the participants is enclosed.

- 2. The Chairperson informed that the matter of stagnation at the level of ITO and for some additional posts for promotion to ACIT level was discussed with the Revenue Secretary. The Revenue Secretary desires the Board to make a presentation of the entire departmental structure with the career prospects at various levels including the stagnation at ITO-ACIT level. He also desired that he would like to listen to the JCA but they must suspend their agitation so that the matter could be considered immediately. The JCA representative's sought time to consult their member's to revert to the Board. The JCA requested that the meeting with Revenue Secretary should be held at the earliest to which the Chairperson stated that she will be seeking time for a meeting of JCA in the first week of November itself and that the Board will be makingthe presentation to Revenue Secretary before that.
- 3. The issue of relaxation of qualifying service in the Group 'B'and 'C' cadres was raised. It was decided that the JCA would give the percentage/number of people who would benefit at various levels by the relaxation sought, which the JCA stated was within the powers of the F.M.
- 4. On the issue of Infrastructure matter, the JCA suggested that, to accelerate the progress of infrastructure proposals, the Pr. CCIT (CCA) should consult the local units of staff/officers association and keep them informed about the progress so that it can be a

participative effort. It was decided that appropriate instructions would be issued in this regard.

5. The JCA also proposed that keeping in view the large number of vacancy in the MTS cadre, which is filled up entirely through direct recruitment, and the non-conduct of the exam by the Staff Selection Commission, the department can explore the possibility of conducting the recruitment at their own level as was being done in other departments. Chairperson directed that Directorate of HRD will look into this aspect expeditiously.
