5. It is desired that whenever any visiting Sr. D.R. proceeds on leave/ training or is away from headquarters or seeks exemption from ITAT duty on any other ground, he/she shall intimate the CIT(DR) ITAT (Admn.), Kolkata, well in advance in writing about his/her non-availability.

6. The officer assigned to hold additional charge(s) shall not be eligible for any claim to additional remuneration under the provisions of **FR 49**.
