I am directed to state that the preparation for updated Civil List of IRS Officers is being carried out by the Directorate of HRD. The Civil List shall inter-alia reflect the following:

i. Name

ii. Civil Code

iii. Date of Birth

iv. Education Qualifications

v. Details of Deputation, etc.

2. Accordingly, it needs to be ensured that the profiles of all the officers are updated. Further, the proposed Civil List is to be issued with photos of the individual officers. At present, only 429 officers have uploaded their profile picture.

3. In this regard, I am directed to request you that the individual officers may be asked to upload their profile photo (and any other personal details) on <u>www.irsofficersonline.gov.in</u>. The path to upload the individual photo is given in **Annexure 'A'** of this letter. It is requested that the individual officers should update their profiles and photos by 20th March, 2024.

4. Accordingly, I am directed to request all the nodal officers of Pr. CCsIT (CCA), under the supervision of the CIT (Admin & TPS) of the region to dispose of all pending profile correction requests received from officers posted in their region by 20th March, 2024. While

updating/editing of the profile, the nodal officers should verify the service records/other supporting documents furnished by the officers. The count of pending requests at the end of nodal officers of Pr. CCsIT (CCA) is enclosed as **Annexure 'B'**.

5. Further, it is reiterated that the responsibility of maintaining the correct and updated Executive Profile is on the individual officer.
