It has been successfully released on 22<sup>nd</sup> March, 2024 at 11:30 AM by the Hon'ble Chairman, CBDT at Chairman's chamber, North Block, New Delhi. Now, as the application has been released, it will be maintained by an external agency as per the contract and the data will be updated from time to time, consequent upon the transfer-posting orders released in future.
- 4. All the Pr.CCsIT(CCA) regions had appointed a Nodal Officer in their respective offices for sharing the updated data of Aaykar Kutumb to this Directorate. The Directorate of PR. P&P appreciates their cooperation for providing updates for the Aaykar Kutumb 2.0 App.
