The promotion is valid for one year or till their reversion to the feeder cadre or regularization of such promotion, whichever is earlier, in terms of Para No.5 of OPT OM No.28036/8/87-Estt.(D), dated 30.03.1988, unless it is further extended as per relevant rules.

The officials are not entitled to exercise the option provided under F.R.22(1)(a)(1) being adhoc promotion. He will be entitled to exercise the option on the regularization against regular vacancy.

3. The continuation of above promotion both ad hoc and regular is further subject to any other order/judicial pronouncement of any court or instructions/guidelines issued by CBDT/DoPT/HRD in this regard.
