2. **Posting:** On promotion, the officers shall continue to discharge their functions and duties on **in situ basis** at their respective present office(s), until further orders.
3. The Adhoc promotions are subject to the following conditions:
 - (i) The Adhoc promotion shall not confer on the officials concerned any right to claim regular promotion as PS nor seniority in the grade of P.S. on regular promotion.
 - (ii) The officials are liable to be reverted to their present cadre at any time without assigning any reason,
 - (iii) The promotion is valid for one year or till their reversion to the feeder cadre or regulation of such promotion, which ever is earlier, in terms of Para No.5 of DoPT OM No.28036/8/87-Estt.(D), dated 30.03.1988, unless it is further extended as per releavent rules.
 - (iv) The officials are not entitled to exercise any option for fixation of pay as provided under F.R.22(1)(a)(1) since the promotion on ad-hoc promotion basic.
4. This promotion is subject to any subsequent O.M/Clarification/Instruction from DoP&T/CBDT regarding the procedure of implementation of the judgement of the Hon'ble Supreme Court dated 26.09.2018 in SLP(C) No.30621/2011, or any such other judgements of the Supreme Court in this regard.
5. The officials who have been given the benefit of pay fixation under the ACP Scheme, 1999/ MACP Scheme, 2008, in the same grade pay/pay level will not be eligible for any pay fixation on above promotion.
