**Promotion:**

**2. Posting:** On promotion, the official will continue to discharge his function and duties on **in situ** basis at his respective present office, until further orders.

3. The Adhoc promotion is subject to the following conditions:
  - (i) The Adhoc promotion shall not confer on the official concerned any right to claim seniority in the grade of ITO or regular promotion as ITO;
  - (ii) The official is liable to be reverted at any time without assigning any reason.
  - (iii) The promotion is valid for one year or till his reversion to the feeder cadre or regularisation of such promotion, which ever is earlier, in terms of Para No.5 of DoPT OM No.28036/8/87-Estt.(D), dated 30.03.1988, unless it is further extended as per relevant rules.
  - (iv) The official is not entitled to exercise the option provided under F.R.22(1)(a)(1) being adhoc promotion. He will be entitled to exercise the option on the regularization against regular vacancy.
4. The promotion of the above official is based on revised seniority list published after giving effect to the decision of N.R.Parmar and Ors. Vs Union of India and Ors. and is subject to change in seniority of any official subsequent to any representation received later on by this office and/or decision of any proceedings pending before any Tribunal/Court/CBDT/DoPT;
5. The above promotion is made against the Vacancy Year 2019 on ad-hoc basis..
6. This promotion is subject to any subsequent O.M/clarification/ instruction from DoP&T/CBDT regarding the procedure of implementation of the judgement of the Hon'ble Supreme Court dated 26.09.2018 in SLP(C) No.30621/2011, or any such judgement of the Supreme Court in this regard. The above officials are liable to be reverted at any time without assigning any reason, as a consequence of it.
7. The official who has been given the benefit of pay fixation under the ACP Scheme, 1999/ MACP Scheme, 2008, in the same grade pay/pay level, will not be eligible for any further pay fixation now.
