2. In this regard, I am directed to inform that online-window for filing the representation against the Transfer & Posting Orders (AGT-2023) in the above-mentioned grades has been opened. All those officers who want to submit their application/representation against the above mentioned AGT-2023 transfer & posting orders or otherwise can do so after logging into the website [www.irsofficersonline.gov.in](http://www.irsofficersonline.gov.in). The window shall remain open from today i.e. 23.06.2023 (Friday) till 27.06.2023 (Tuesday). The Pr. CCsIT/ Pr. DGsIT are requested to approve the online options submitted by the officers positively by 28.06.2023 (Wednesday).

3. I am further directed to reiterate that the officers shall file their representation (where there is a change of region/ station/ post) only after joining their new region/ station/ post except where prior approval has been obtained from the Competent Authority.

4. Furthermore, I am directed to inform that no representation/application other than those filed online shall be entertained.
