No. HRD/CM/102/28/2013-14/27 dated 4th March, 2014 and subsequent Corrigendum from F. No. HRD/CM/102/28/2013-14/4488 dated 17th October, 2014 and in suppression of all earlier orders on the subject, except as respects things done or omitted to be done before such suppression, the Principal Chief Commissioner of Income-tax, West Bengal and Sikkim hereby directs:-
